A 16-point "manifesto" to be read Sunday, Oct. 30, in Trinity Lutheran Church, Taneytown, will begin a per-iod of self-examination and renewal at the church as well as in 6,217 other congregations of the Lutheran Church in America.

The Rev. Howard W. Miller, pastor of Trinity, said the manifesto con-sists of a "check list" of character-istics that a congregation alert to modern times must consider.

The document will be read from the pulpit on Reformation Sunday and then studied and discussed with the help of material being prepared by the LCA Executive Council, Pastor Miller said.

At the 1964 convention, the LCA became concerned that some of its congregations may have lost touch with modern changes in private and community life, and it order-ed a study of the nature and mission of the congregation.

We all like to give people what they want, enjoy, and expect. That is why it is so often difficult to do what God want us to do: what he wants is in conflict with what people want. Unfortunately, we often find it more unpleasant in the short run to displease people than to say "No" to God.

### When God Commands

Thus, we are constantly in the middle of the conflict between what God wants of us and what others expect of us. John Milton, the English poet, put it so well: "To every good and peacable man it must in nature be a hateful thing to be a displeaser and molester of thousands: much better would it like him to be a messenger of gladness and contentment. But when God commands to take the trumpet and blow a dolorous and jarring blast, it lies not in mans' will what he shall say or what he

shall conceal."

One of our most common misconceptions is the notion that being a spokesman for God (what the Old Testament calls a proph-et) is a romantic or enjoyable vocation. That isn't the way Jeremiah looked at it when God's call came to nim. Told by God that he had a prophetic message for him to deliver, Jeremiah pro-tested: "Ah, Lord God! Behold, I do not know how to speak, for I am only a youth", (Jeremiah 1:6 RSV) You've got the wrong man, Lord, that's not up my line.

Jeremiah wasn't the first spokesman for God to react that way, nor the last. Moses, when confronted with the great message he was to take to the people of Israel, had said virtually the same thing: "Who am I that I should go to Pharaoh, and bring the sons of Israel out of Egypt?" There are few of us today who don't respond in a similar fashion: Who am I, Lord, that I should attempt to do that!



In order to provide a first-rate public school system, Carroll County must offer the facilities and benefits necessary to attract dedicated teachers. 
