

### Most Anything At A Glance

As we enter into the holy Christmas holidays there is much to be thankful here in Emmitsburg. Many of us are prone to gripe a bit and complain this is a ghost town, etc. On the contrary, we are growing and our material wealth for the area seems to increase with each year. Within the past year we have seen this growth: the million-dollar pleasure resort, Charnita, has opened; our new Post-office is under construction; several new homes have been completed; new Mother Seton School is now open and occupied; open house was held at St. Joseph's Provincial House; the Bell Tower at the Grotto has been finished and officially dedicated; the new science building at St. Joseph College is almost ready for occupancy; new streetlights are being installed, etc. These are just some of the projects that come rapidly to my mind. There are others, such as the annexation by the Town within the past year of almost 150 acres of ground, including St. Joseph's Provincial House which is now in the process of being annexed. Yes, there is steady growth here and it should continue for some years to come. We have lost some small businesses through economic conditions and some by disaster. On the other hand we have gained several including an electrical store, snack bar and poolroom and an insurance agency. In this day and age the lot of the small business is a rough one and one by one they fall by the wayside. This is not to say that the Town is becoming decadent. Almost everyone has a car these days and shopping distances to other larger towns nearby are becoming shorter with newer roads and better cars. People look forward to driving a few miles these days to do their shopping. It is proving more apparent these days that the small town merchant must be an acute and prudent merchandiser in order to be able to survive the exodus of shoppers to other towns. There are no Government subsidies for the little merchant and his share of the tax burden becomes heavier and heavier as time goes by. He must fight his own battle unaided and this my friends, is getting tougher every year.

On the derogatory outlook we have received some unfavorable publicity on our lack of water here. The numerous Route 15 bypass wrecks and fatalities didn't bring us any claim to fame, and the fracas caused by the brutal beating of our police chief was nothing to bring goodwill to the community. But then, what town or city doesn't have its share of this sort of thing? Losing our public high school wasn't praiseworthy by any stretch of the imagination but then our colleges are getting larger each year and this will offset some of the lost prestige.

Looking back over last year's Chronicle of this date there is a parallel between the record of the Mount basketball team of last and this year's new edition. The record, to my amazement, was exactly the same. At Christmas in 1964, Jim Phelan's team had won seven straight games—the same as the record stands today. And on this end of the good news theme on behalf of myself and the boys in the composing room, I take this opportunity to wish you all a Merry Christmas!

### Mount Team Continues Win Streak

Jim Phelan's Mountaineers will return to the basketball wars on January 4 when the potential powerhouse meets Catholic U on the Emmitsburg court.

The Mounties have won seven straight contests while losing none. Among the Phelanmen's conquests has been highly-touted Evansville, Ind., considered high among the country's small colleges, and last year's top small college team. The Blue and White polished off Evansville at the Baltimore Civic Center last Thursday night 83-81.

This win should gain the Emmitsburg team some national attention.

The Civic Center was turned into a house of thrills by the performance of these two small college basketball stalwarts from the opening tapoff to the final desperation attempt by Howard Pratt to tip in the tying basket. The contest was close throughout the first half and neither team was able to gain more than a five-point lead which the losers held at the end of the first stanza. Fred Carter's shooting and Jim Livelsberger's floor play kept the winners close in the first half. Carter, who was named by the sports-writers attending the doubleheader as the outstanding player of the night, ripped through a total of 35 points in a fantastic display of basketball ability.

The second half began with the Mount down by 45-40 and the margin remained that way for the first six minutes. Then came the darkest moment of the night for the Mount outfit as the Evansville team ran off seven straight points and gained a 64-53 lead with 12 minutes to go in the contest. However, the Mount refused to give up and turned on the steam at this point to race into the lead by a 70-69 score with 6:12 on the clock. This comeback was sparked by a magnificent steal and pass to set Carter up for a field goal by Livelsberger.

The lead continued to change hands in the remainder of the game. Bob Sutor checked back into the game after being out with a sprained ankle and tossed in a short jumper to put the Mount back on top 80-79 with 1:10 showing on the Civic Center clock. Watkins then threw in a turnaround jump shot to regain the lead for the Aces at 81-80 with 44 seconds in the game. Carter was then fouled and calmly pumped through his free throw to set the last-second heroics by Mike Lyons. The Mountaineers worked the ball around until Lyons drove for the bucket to score the biggest goal of his career and set the Mt. St. Mary's students wild with delight.

Sutor and Livelsberger both shared the spotlight with Carter. Sutor finished with 15 points for the evening. Livelsberger had the biggest night of his career as the Senior hit on key shots and played a fine floor game. He had 10 points to follow Carter and Sutor in the offensive totals. Carter was hitting shots from all over the court and was tough under the boards.

The losers outshot the Mount by a 45.3 percentage to a 43.7 shooting average. But this didn't halt the Mount students from rushing onto the court and cutting down the nets at one end of the court.

Msgr. Mulhearn attended Mount St. Mary's Seminary and was ordained in 1921.

Funeral services will be held today (Friday) in Chester.

### Charnita Hears Successful Financial Report

Charnita, this district's newest resort area, had expenses of \$568,887.27 during the first nine months of operation, according to a report of a Baltimore certified public accountant, to the board of directors of the pleasure resort just three miles northwest of Emmitsburg.

The report says expenditures included \$98,330.69 for salaries; \$84,150.87 for sales commissions and advertising; \$32,470.33 for supplies and materials; \$212,206.32 for road development costs; \$55,100.50 for miscellaneous development and land costs; \$23,441.16 for contract services; \$9,593.94 for depreciation and amortization; \$6,729.71 insurance; \$13,474.07 taxes; \$13,596.03 interest; \$5,364.07 vehicle maintenance; \$4,662.43, legal services. \$1,703.88 travel and entertainment; \$3,694.65 office expense and utilities; \$3,268.63 miscellaneous administrative expenses; \$1,100 directors' fees.

Income was listed as \$699,882 including \$653,050 from the sale of lots; \$28,515 from the sale of houses and \$18,317.08 for miscellaneous sales and rentals, according to the consolidated income statement.

The net income listed before provisions for income taxes was \$130,994.81. Taxes totaled \$2,409.72, leaving \$68,585.09 as the "net income transferred to retained earnings."

The report showed Charnita a million-dollar concern making about 10 per cent profit before taxes. Shirley's report listed the corporation as having total assets of \$1,237,461.05.

Among assets listed as of September 30 were \$123,689.65 in accounts receivable; \$45,834.07 in prepaid expenses; \$50,696 cash on deposit or on hand.

Fixed assets include land development valued at \$213,641; golf course land improvement, \$258,736; land and building for company use, \$231,794.91; land improvements and buildings in the ski area, \$148,161; land and buildings for rental, \$21,400; equipment, \$66,703.70; autos and trucks, \$16,050.30 less \$9,427.64 for depreciation and deposits on equipment of \$40,475, representing the amount paid to September 30 on the \$229,100 worth of equipment for construction of the ski area. Other assets totaled \$34,705.19 including investments, reserve accounts, etc.

Current liabilities total \$686,880.35 including \$306,976.15 accounts payable; \$106,901.15 accrued expenses; \$210,523.12 notes and mortgages payable. Fixed liabilities include \$212,385.14 mortgages. Capital totals \$296,585.09, including \$162,000 in Class A common stock and \$42,600 in common capital stock.

### Registrar Represents Local College

Sister Felicia, Registrar at St. Joseph College, represented the college at a recent conclave of the regional segment of the American Association of Collegiate Registrars and Admissions Officers. More than 500 representatives of 280 colleges and universities from six states attended the annual convention of the Middle States Association of Registrars and Admissions Officers in Atlantic City.

The keynote address, "College Administration and Crime," was given by Dr. Jacques Barzun, Dean of Faculties and Provost at Columbia University.

The convention concerned itself with experience exchanges both for admission officers and registrars, two year-four year college institutional relationships, the Economics Opportunities Act, the college transcript, foreign students, financial aid, the secondary school transcript, management information systems, and graduate admissions.

### Mother Seton's Sainthood Cause Advanced

Mother Elizabeth Ann Baley Seton, founder of America's first native Roman Catholic sisterhood in Emmitsburg, has moved a step closer to sainthood.

Enrico Cardinal Dante of Italy, official proponent for her canonization, placed the cause before the Congregation of Rites at the Vatican recently. Her case was first introduced in 1940.

It was not known how long the process would take but action for her recent beatification came very rapidly. She was beatified on St. Patrick's Day in 1963.

Blessed Mother Seton will be the first native American saint when canonized. To achieve sainthood her sponsors must prove that through her intercession, two miracles occurred after her beatification.

Mother Seton was credited in the cure of a Baltimore girl, now 17, who had leukemia, at the age of five. She is also credited in the cure of a New Orleans nun from cancer. Both women prayed to Mother Seton.

Born a Protestant in New York in 1774, she was married and widowed 10 years later with five children. Her husband died in Italy.

She was converted in 1805 and founded her community at Emmitsburg in 1809. She died here in 1821, having founded the Sisters of Charity, America's first native sisterhood. She also founded the first parochial school in America.

### National Grotto Designated Public Oratory

The Shrine of Our Lady of Lourdes, near the campus of Mt. St. Mary's College has been elevated to a public oratory, according to an announcement Friday by Lawrence Cardinal Shehan, archbishop of Baltimore, in the Baltimore Diocese Catholic Review. The elevation was decreed in a document dated December 8, authorized by Cardinal Shehan and executed by Msgr. Porter J. White, chancellor.

Msgr. Hugh J. Phillips, director of the Shrine, was named chaplain of the Grotto, which now will be known as the National Shrine Grotto of Lourdes. The appointment was made by the Council of Mt. St. Mary's College and was confirmed by Cardinal Shehan.

Included in the Shrine, besides the Grotto, is the Pangborn Memorial Campanile, which was dedicated in May, 1965, a gift of the Pangborn Foundation, Hagerstown. The campanile stands at the entrance to the Shrine and is a 95-foot tower with a 25-foot gold-leaf bronze figure of the Blessed Virgin. The exterior is of rough-hewn stone from a quarry on college property.

The Shrine, a favorite retreat for Mother Seton, was a private shrine until 1958, and today pilgrimage attendances average 20,000 to 25,000 persons a month. The Corpus Christi Chapel, erected in 1906, marks the site of the original Grotto, and the Calvary group, a crucifixion tableau is set against a background of mountain foliage to illustrate the natural beauty which inspired the founder of the Shrine. Handsome copper and stone Stations of the Cross line one of the pathways of the Shrine.

### Law Case Sent To Brunswick

No date has been set for the trial of five men charged with assaulting Emmitsburg Policeman Wilmer E. Law.

The location of the trial has been transferred to Brunswick, at the request of the defendants' counsel, Atty. Edwin F. Nikirk, of Frederick. Brunswick Magistrate William B. Gross said he will confer with the state's attorney to set a date for the trial.

### Water Situation Remains Critical; Future Discussed

Supplying water to Emmitsburg is a day-to-day operation, Public Works Director J. Norman Flax said this week. By this, the Director explained, only enough water is being pumped to supply the Town from day to day. Storage space in No. 2 reservoir does not permit over one day's storage.

Presently water is being pumped from Tom's Creek on the Keilholtz farm west of Town, to No. 1 reservoir which is used as a sediment basin, then relayed by pump up the mountain to No. 2 reservoir where it is chlorinated and passed into the water mains for use by the Town.

At the present time two wells are being used at 50% capacity to augment the pumping supplies. Storage space is the real problem. There appears to be sufficient water flowing in Tom's Creek but the first two reservoirs are too small to hold much over a day's supply. The two largest of the reservoirs, No. 3 and Rainbow Lake, are not being used. This week Rainbow Lake was emptied into No. 3 leaving just enough water remaining to preserve the fish there. Workmen are currently installing a new valve house in the lake and for that reason it had to be drained into No. 3 reservoir. Plans call for raising the spillway level nine inches which will increase the capacity of the lake by several million more gallons.

Flax said the Town is sparing no expense in an effort to supply the Town with water and this week a new pump was purchased to take water from No. 1 to No. 2 reservoir. Flax hopes to be able to convince other Town Officials to look favorably on the construction of a by-pass line leading from Tom's Creek to No. 3 reservoir, some 1600 feet up the mountain, where the water can be utilized in the filtration and chlorinating system. Cost of this project would be in the neighborhood of \$6,000 and some Federal money would be available for the project. The installation would be a permanent one and would apparently solve the water problem here as long as sufficient water flowed into Tom's Creek. The Town is holding the steel storage tank of 250,000 gallons in reserve for any fire emergencies.

Commissioner Flax explained that it is the hope of the Town Council to be able to provide sufficient water to the colleges when they reopen for the new semester next month. In the meantime the strict water ban remains in force until such time as the Mayor and Council announce its termination.

A Christmas Eve Service will be held at 11:00 p.m. at Elias Lutheran Church on Christmas Eve. Special music has been planned by the Choirs of the Church under the direction of Mrs. James Sanders and the organists, Mrs. Donald Eyer and Miss Ruth Shuff. The Christmas Eve message, "God's Second Creation" will be preached by the host pastor, Rev. Ronald Fearer. Also assisting with this community service will be the Rev. John Chatlos, Pastor of the Incarnation Reformed Church.

The traditional candle lighting by all in attendance will conclude the service with music by the joint choirs of the Church and the congregation uniting to sing, "Silent Night, holy night."

**Origin Of Christmas Caroling Given**

Christmas caroling is almost as old as Christmas itself—though not in the form we know it.

An early historian wrote that in the Second Century the bishop of Rome urged his people to sing "in celebration of our Lord." Christmas hymns go back to the Fifth Century, when most of them were written in Latin.

St. Francis of Assisi is regarded as the father of caroling as we know it, according to World Book Encyclopedia. In 1223, St. Francis placed a creche (miniature Nativity scene), in a hermitage in Greccio, Italy.

After this many churches began displaying a Nativity scene at Christmas, and soon the people began acting out the Christmas story. The actors composed carols to sing with their Nativity plays and after the plays they would stroll down the street singing. In that way, street caroling was born.

Joseph Mohr, a pastor in Oberndorf, Austria, composed "Stille Nacht," or "Silent Night," on Christmas Eve, 1818. Franz Gruber, the local schoolmaster and organist, composed the music the same day, and the hymn was sung for the first time at Midnight Mass that night.


Charles Wesley, brother of John Wesley, wrote, "Hark! The Herald Angels Sing!" in 1739. Philip Brooks, a noted Boston clergyman, wrote "O Little Town of Bethlehem" in 1868 after visiting Bethlehem.

Though not a carol, Handel's noble "Messiah" is a Christmas tradition. It first was performed in Dublin in 1742. "Joy to the World," written in the early 18th Century by Isaac Watts, was set to the music of a segment of the "Messiah." "While Shepherds Watched Their Flocks by Night," written in 1703 by Nahum Tate, was set to music taken from "Siroe," an opera by Handel.

No one knows who wrote "The First Noel." It first appeared in print in 1833 in a book called "Christmas Carols Ancient and Modern," and is believed to be very old.

The author of "God Rest Ye Merry, Gentlemen," also is unknown, but he lived before Shakespeare.

So if you should go caroling this Christmas season, think of other carolers of years gone by, of the people of Charles Dickens' time in their beaver hats and cut-away coats, of English villagers in hose and jerkin, of good St. Francis, and of the priests of the time of the Christian Roman Empire who, before caroling as we know it existed, sang "in celebration of our Lord."

#### CHARTER AMENDMENT RESOLUTION NO. 11

A Resolution of the Burgess and Commissioners of the Town of Emmitsburg, Maryland, adopted pursuant to the authority of Article 23A, Section 19 of the Annotated Code of Maryland (1957) 1965 Cumulative Supplement, entitled "Corporations — Municipal", sub-titled "Annexation", said Resolution being a Resolution to amend and enlarge the corporate boundaries of the Town of Emmitsburg, a Municipal Corporation of the State of Maryland, by annexation of thirty-five (35) acres of land, more or less, continuous and adjoining to the existing corporate area by repealing and re-enacting Article I, Section 2 of the Charter of Emmitsburg, entitled "Incorporation and General Government Resolution No. 10, passed on September 6, 1965.

Section I. Whereas "The Sisters of Charity of St. Joseph's", a body corporate of the State of Maryland, is the owner of 35 acres of land, more or less, contiguous and adjoining to the existing corporate area of the Town of Emmitsburg; and

Whereas, "The Sisters of Charity of St. Joseph's" has requested the Town of Emmitsburg to include 35 acres of land within the corporate limits of said Town; and

Whereas, by written petition, signed by not less than 25% of the persons who reside in and who are registered as voters in County elections in the precinct in which the territory to be annexed is located, the said residents and voters have requested such annexation; and

Whereas, the Burgess and Commissioners of the Town of Emmitsburg have decided and do hereby resolve that the general welfare of the Town will be best served by the annexation of the 35 acres of land, more or less, as hereinafter set forth;

Now, therefore, be it resolved by the Burgess and Commissioners of the Town of Emmitsburg, Maryland, that Article I, Section 2 of the Charter of Emmitsburg, entitled "Incorporation and General Government", subtitled "Boundaries" be and the same is hereby repealed in its entirety and re-enacted to read as follows:

#### "Section 2. BOUNDARIES.

The taxable limits of said town shall be as follows: Beginning at an iron pipe S. 67° 34' 24" E. 17.91 ft. from the southwest corner of Lot #6 fronting on Flat Run Drive and shown on the Plat of Section 3 of "Emmit Gardens" dated October 1, 1962 and prepared by Elmer St. C. Maxwell & Associates, Professional Engineers, said Plat being made a part of this description, and running from said beginning point (1) S. 64° 39' 37" E. 403 ft. to a pipe; thence (2) S. 64° 39' 37" E. 383.62 ft. to a pipe; thence (3) N. 24° 26' 11" E. 813.47 ft. along the eastern boundary of said Section 3 of "Emmit Gardens", said boundary being also the western boundary of the land of the Emmitsburg Civic Association, to a pipe in the south boundary of the State Road Right of Way for Maryland Route #97; thence (4) with Rt. 97 in a westerly direction along the northern boundary of Emmit Gardens 450 feet, more or less, to a point where the north boundary of Lot #27

(fronting on Meadow Lark Drive) intersects with a southerly extension of the West side of the Harney Road; thence (5) by straight line N. 46° E. across Rt. 97 to the Southwestern corner of the 13.692 acre tract of the "Three D, Inc." thence with the West side of the Harney Road and the Eastern boundary of the "Three D, Inc." tract (6) N. 46° E. 551.87 ft. to a point; thence (7) leaving said Road N. 44° W. 248.90 feet to a point; thence with a curve to the left having a radius of 1023.02 feet and an arc distance of 583.64 feet and a chord distance and bearing (8) N. 60° 20' 39" W. 575.76 feet to a point; thence (9) N. 76° 41' 16" W. 420 feet to a point on the west right of way line of U. S. Rt. 15; thence with U. S. Rt. 15 (10) N. 13° 18' 44" E. 780.28 feet more or less, to a point; thence (11) N. 02° E. 51.00 feet to a point; thence (12) N. 07° 35' 35" E. 50.25 feet to a point; thence (13) N. 11° 35' 27" E. 100.04 feet to a point; thence (14) N. 16° 01' 27" E. 100.12 feet to a point; thence (15) N. 18° 43' 01" E. 109.44 feet to a point; thence (16) S. 87° 18' 19" W. 777.59 feet to a point; thence (17) S. 89° 38' 38" W. 1015.75 feet to a fence post; thence (18) S. 75° 10' 25" W. 453.28 feet to a point in the old corporate boundary, said point being in the bed of "Flat Run" and running thence up the bed of "Flat Run" (19) N. 43° 51' 29" W. 141.37 feet to a point; thence (20) N. 28° 46' 25" W. 413.51 feet to a concrete monument near the northeast corner of Lot No. 178 as indicated on the Plat of Emmitsburg; thence (21) N. 31° 14' 56" W. 59.10 feet to a point on the north wall of a small bridge over "Little Run"; thence (22) S. 55° 10' 13" W. 140.09 feet to a concrete monument in the bed of Little Run; thence (23) up the bed of Little Run to a monument in the road leading from Emmitsburg to Waynesboro; thence (24) S. 17° 50' 40" W. 958.91 feet to a concrete monument; thence (25) S. 57° 10' E. 1839.00 feet to a concrete monument on the east side of a lane between the properties of George Sanders and D. R. Stansbury; thence binding on the east side of said lane (26) S. 32° 09' 05" W. 144.00 feet to a stone; said stone being a property marker of The Sisters of Charity; thence binding on the property of The Sisters of Charity the three (3) following courses and distances, (27) S. 71° 07' 38" E. 1138.52 feet to a monument on the east side U. S. Route No. 15; thence (28) S. 77° 48' 42" E. 1463.43 feet to a point; thence (29) N. 60° 33' 53" E. 857.57 feet to a granite monument; thence (30) N. 06° 22' 45" E. 475.61 feet to a point; thence (31) N. 89° 03' E. 644.45 feet to a concrete monument marked #28 near the south line of the property of The Emmitsburg Development Company; thence (32) by straight line in a northeast direction 483 feet, more or less, to the point of beginning, and for sanitary purposes, health and police powers, the power and authority of the corporation shall extend to the distance of one mile from the boundaries as above set forth.

Section II. And be it further resolved by the authority aforesaid that in accordance with the requirements of Section 19 of said Article 23A of said Annotated Code, the conditions and circum-

stances applicable to the change in boundaries and to the residents and property within the area to be annexed shall be as follows:

1. The annexed area shall be subject to Section 4 of Article I of the Charter of the Town of Emmitsburg.

2. The Sisters of Charity of St. Joseph's will be responsible for the following:

a. Preparation and filing with the Town Clerk of plats showing the exact location of all underground facilities.

b. All storm and surface waters shall be channeled into Flat Run or other suitable disposal point as approved by the City Sewer Superintendent or other official designated by the Burgess and Commissioners.

3. The Town will be responsible for the following:

a. Taxing the undeveloped land only in the same manner as other similar property within the town limits is taxed.

Section III. And be it further resolved that the exact area proposed to be included in the change of boundaries is as follows:

Beginning at the end of the 27th line of the present boundaries of said Town and running thence with same along the east side of U. S. Route No. 15, also known as South Seton Avenue (1) N. 19° 16' 28" E. 739.91 feet to a concrete monument at the corner of a cemetery; thence (2) running on the South side of said cemetery S. 71° 02' 33" E. 426.15 feet to a concrete monument at the southeast corner of said cemetery; thence (3) with part of the 30th line of the present town boundaries N. 89° 03' E. 1589.55 feet to a newly installed monument; thence by the proposed new boundaries of said Town (reversed) the following three courses and distances (4) S. 06° 22' 45" W. 475.61 feet; (5) S. 60° 33' 53" W. 857.57 feet; (6) N. 77° 48' 42" W. 1463.43 feet to the point of beginning.


Section IV. And be it further resolved that in accordance with Sub-Section 19 (d) and Sub-Section 13 (d) of said Article 23A, the Burgess of Emmitsburg shall cause a public notice or copy of this Resolution to be posted on the front window of the Town Office from December 6, 1965 to January 17, 1966 inclusive, and a copy thereof to be published once a week for four (4) successive weeks beginning December 10, 1965, in "The Emmitsburg Chronicle", a newspaper of general circulation in the Town and the area to be annexed, and notifying all persons that a public hearing will be held by the Burgess and Commissioners on this Resolution at the Town Office at 8:00 o'clock p.m. on January 17, 1966, said newspaper publications to be on Dec. 10, 17, 24 and 31, 1965. Final action thereon will be taken on or about Feb. 7, 1966 and, if adopted, the Resolution shall become effective on March 31, 1966 and the property to be annexed shall be subject to municipal taxation beginning July 1, 1966.

Section V. This resolution was regularly introduced in the legislative body of the Town of Emmitsburg on December 6, 1965.



**Babson's Point Of View On: End Of Industry-Wide Labor Bargaining?**

BABSON PARK, Mass., Dec. 16—Arguments have been common over the pro's and con's of industry-wide labor negotiations, such as have existed for some time in steel. For the most part, steel executives have tended to favor such bargaining in their field. They have pointed out that this prevents the union from tackling one of the weaker companies, forcing on it an unrealistically costly contract, then foisting this on the other firms.

Out of the coal industry came the idea of solid-front negotiations, developed by its "Big Daddy", John L. Lewis, president of the United Mine Workers. This spread in 1955 to the Steelworkers, an off-shoot of the UMW. But, the way it looks now, the scene is shifting again. **Union Beginning To Wonder**

Most union authorities, at least in steel, have seemingly been satisfied with industry-wide deliberations. Now they are inclined to take a second look. After all, the United Automobile Workers did better than the Steelworkers in their latest settlement terms; and they bargained with each concern individually. So, steel labor leaders have established a committee to see if they can't improve their bargaining techniques.

Insiders know that many of the rank and file in steel want the union to take on the companies one by one. They think they can get more that way in wages and benefits. Also they believe they will have a brighter chance of settling special job differences of a non-economic nature at the company level. Union leaders are listening to suggestions. And it is more than possible that the practices of block negotiations with the biggest companies in an industry may eventually be dropped in steel, and possibly in some other fields.

**Lessons Learned In 1965**

Labor planners recognize that, in steel, they are under a new regime. I. W. Abel has replaced David J. McDonald as president of the Steelworkers, and he is not afraid to change tactics if he thinks it will be more rewarding for his membership. Negotiations this year seemed cumbersome to many unionists. Also, they feel that the government will always intervene when a whole industry is threatened, as it did in 1965 and other years before that. Actually, such intervention has almost favored labor. But still, both sides are strong for free collective action.

Several of those on the new bargaining-study committee are known to have suggested company-by-company attacks earlier this year when the going got tough. Nothing came of it; but at least it showed how the wind is blowing behind the scenes in the union. Hence change may very well be on the horizon. It is expected that the committee will work up some proposals on this matter for consideration at next year's convention.

**Fewer Big-Scale Work Stoppages?**

What will it mean to labor in general if industry-wide negotiations are dropped? For one thing, labor would then have little chance of forcing huge strikes that threaten the nation's welfare. This, in turn, would lessen the necessity for government interference at — od in the shadows behind — a bargaining table. As we have said, both management and organized labor would prefer to fight their own battles to the end without having the government step in.

It might create more small walkouts, but would undoubtedly mean fewer big tie-ups. One employer move in this direction has been seen in the New York newspapers. Originally, all of the city's papers closed down if one publisher was struck. But in the blow-up before last, one paper withdrew from the arrangement and kept printing while the others closed down. This year, two publishers stayed out of the "united front" against the union. So, once again, it looks as though both employers and unions are headed away from the controversial concept of multi-company bargaining.







"Refrain from drinking at parties if you must drive home.

"Your own life may depend upon it!"
