

Largemouth and smallmouth bass, of course. Have we brought you in a circle just to create confusion? Not really, say the fishing experts at Mercury outboards. Being able to readily identify large-mouth and smallmouth bass is important because seasons and limits are usually differ-

and limits are usually differ-ent for these two species. Largemouth bass, found throughout the country, are not particular about whether they live in streams or lakes. The largest specimens of this specie, though, are found in lakes. And the biggest bass are generally taken in southern waters where they enjoy a 12-month feeding season. Bass in northern lakes will hibernate-or at least become semi-dormant - during cold worther weather.

Smallmouth bass, on the other hand, are considered a Yankee fish, ranging as far south as the Ozarks. Their southern extension has been enhanced by man, since these enhanced by man, since these fish were originally found only in the more northern states. They prefer cold streams and lakes, particu-larly those with gravel bot-toms. Swift water is preferred to sluggish streams.

Largemouth bass can be distinguished from their little-mouthed brothers by comparing three points; the lower jaw of a largemouth bass extends beyond the eye when closed, while a smallmouth bass' mouth does not; the spiny mouth does not; the spiny part of a largemouth's dorsal fin is almost separated from the soft rear section; and, third, largemouth bass have no scales overlapping the base of the soft dorsal fin, while smallmouth bass do. These tips from the fishing gang at Mercury should help you keep largemouth and smallmouth bass separated. But, what can you do about Kentucky, white, yellow, sil-ver and spotted bass? We'll save that for another time.

PIMIENTO-LINED BAKED AVOCADO 2-3 medium avocados (firm) 1 (4 oz.) can or jar pimientos 4 T. chopped celery 4 T. butter or margarine 2 tsp. prepared mustard 4 T. chopped sweet pickle 1 13 oz. can white tuna, packed in water.

Cut avocados in half lengthwise. Remove seed, peel. Sprinkle with lemon juice. Heat butter or margarine and cook celery until tender. Add flour, stir to smooth paste. Gradually add milk to make the sauce. Add mustard, pickle, salt, pepper, tuna. Mix without breaking tuna too small. Line avocado cups with pimiento. Add leftover pimiento bits to tuna mixture. Fill cups, piling high. Place in baking dish with half-inch of water and bake at 350° for 20-25 minutes. Serve hot.





The measure would require employees of the Executive Branch, when they are asked to testify before Congress, to grants us at least the pleasure of their company even when they intend to deny us the illumination of their wisdom by invoking that doctrine which is called by legal scholars "Executive Privilege.'

This doctrine is an inherit-ance of our government from the old royal government of Great Britain. It was the doctrine by which the King re-fused to share his secrets with the Parliament and it has been a matter of very bitter controversy in our Republic ever since we broke away from that royal government of Great Britain, and since our legislature, the national Congress, has sought to legislate on subjects which the President, the Executive, from George Washington down to Richard Nixon has felt were matters within the exclusive perogative and privilege of the Executive Office.

This bill represents, however, a thoroughly modest move, the very least the Congress can do to reassert its role as a separate but equal branch of government. Few principles are more basic to our system of government than the separation of powers but we seem to have forgotten over the years and over the decades that before you can have a genuine separation of powers, you have to have some genuine powers to separate and today, in relation to the Executive Branch of government, the Congress is in many respects decidely a second, if not a third or fourth class power.
