Letter To The Editor

Recently numerous property owners in this area receiving tax assessment notices increasing their assessments by 50% to 100% or more. These assessments will result in the same or a greater percentage increase in the total amount of taxes due to be paid by them on July 1, 1973.

Property owners can protest these increases by taking the following listed steps:

a. Immediately, but no later than 20 days from the date of the notice of assessment, make a request in writing to the "Supervisor of Assessments for Frederick County, Winchester Hall, Frederick, Md. 21701" for a hearing to protest the increase. In your letter refer to the number of the Assessment Notice or Notices and the name or names of the owners. Keep a copy of your letter and file it with the Assessment Notice.

b. Upon receipt of an assessment reflecting the results of the meeting with the assessor, request a hearing before a Court, or Board, appointed by the County Commissioners to act in their stead in hearing such appeals.

c. If unsatisfied with the result of the second appeal, request a hearing by the Maryland Tax Appeals Court. The Tax Appeals Court will probably give the property owner an appointment to appear before an Examiner in his home county (Frederick).

d. If unsatisfied with the findings of the examiner the property owner can elect to take his case before the full Appeals Court. No attorney is required at any level and, except for travel expenses and loss of time, no expense to the property owner is incurred.

e. To protect his interests and possible benefits from his own appeal, or those appeals of other taxpayers or groups of taxpayers in Frederick and other Counties, it is important for each property owner to make an initial appeal to the Supervisor of Assessments as outlined above.





Perspectives In Learning By Hazel Brown

The National Education Association recently conducted a poll asking teachers to indicate the most significant teaching problems. The results are very interesting and somewhat surprising.

Sixty per cent of the teachers questioned indicated that the worst problems were the wide range of student achievement, too many students indifferent to school, too many noninstructional duties and working with too many students each day.

The teachers seemed to suggest that the troublesome situations could be remedied, but they felt that more time was needed with individual students in order to meet success. Meeting individual needs could be the key to various solutions. It is logical to think that students' attitudes and interests

would improve if teachers were able to diagnose learning problems and then provide individual instruction.

Student behavior in the classroom was reported to be a problem to fifty-four per cent of the teachers questioned but only seven per cent found student use of drugs to be a major concern. Chronic absence and dropping out of students was recognized as a moderate concern by thirty-one per cent of the teachers. This relatively low level of concern could be because not all the teachers questioned were teaching at a high school level. Elementary teachers would be more apt to find this an insignificant concern.

All the items directly related to instruction, instructional materials, and classroom environment were considered to

be important by thirty per cent or more of the teachers. When asked what could be possible solutions to the problems, the teachers thought they needed more help from specialized staff members, teachers aides, and from the parents and the community.

Many teachers indicated a need for time to develop new programs which would increase their effectiveness. They also wanted meetings with parents of the problem students and time for pupil-teacher conferences. The need for communications with principals and administrators was indicated.

This survey was done by the National Education Association as a step for identifying the needs of their membership, but the information it offers has much broader usage. It gives all educators a chance to identify priority concerns and then seek solutions. Principals, too often, feel their problems are unique and fail to move outside their group to find the answer.

More surveys like this one should be conducted so that teachers can speak out, share concerns, and seek solutions.







Higher Social Security Payments

About 150,000 retired workers and their families will get higher social security payments starting in 1973 under a special minimum benefit provision of the new social security law, according to Carroll A. Jones, social security manager in Frederick.

People who worked over 20 years in jobs covered by social security, but had relatively low annual earnings, may be helped by the special minimum provision, Mr. Jones said.

The special minimum benefit ranges up to \$170 a month for workers who retire at 65 with 30 or more years of coverage under social security, he said. A couple can get up to

\$255. Benefits for people who apply before 65 will be reduced because the benefits will be paid for a longer time.

The new provision is effective January 1973.

Retired people who will get a benefit increase under the new law don't have to apply for it. The increase will be

paid starting with checks delivered in early April, Mr. Jones said.

People already getting more than the minimum will continue to get their regular checks. Additional benefits to be paid under the new provision will amount to about \$18 million in 1973 and \$20 million in 1974.
